By direction, I am to inform that the following amendments have been made in the Ph.D. regulations, vide reference 1st cited:

- 1. Panel of Examiners: (a) The Research Supervisors shall give a panel of examiners for evaluating the Ph.D. thesis, with or without attaching the consent letters of the examiners. However, the Supervisors must ensure that the examiners listed in the panel accept to evaluate the thesis when the request is sent from the Research Section so as to avoid any delay in completing the process of evaluation.
 - (b) The Research Supervisors shall submit a panel of four foreign examiners drawn from ranked/reputed Universities / Institutions from any foreign country (not exceeding two from a country) for evaluating the Ph.D. thesis.
- 2. INSPIRE Candidates: The INSPIRE candidates (who have qualified in the screeing test for the DST-INSPIRE Fellowship) will be allowed to continue the Ph.D., Programme, with the condition that they should clear the Ph.D., Pre-Registration Qualifying Entrance Examination within two attempts before submitting the thesis.
