In accordance with the communication by the Government and by direction, all the Research Supervisors are requested to take the following matter into consideration when guiding Ph.D. Scholars:

1. Research Supervisors are requested to treat their Research Scholars properly with due regard.
2. Do not humiliating / harassing the Research Scholars with personal chores.
3. Apart from academic works, do not ask the Research Scholars to do household chores of the guides.
4. Do not ill-treat the research scholars.
5. Do not force the research scholars to spend a sizable amount to complete their research projects / viva by way of cash and kind.
6. If anybody is found to resort to such tactics or if any such incident is reported, then strict action will be initiated against those erring guides.
