About Alagappa University

Alagappa University is located at Karaikudi in Tamil Nadu and occupies a sprawling 440-acre greenery and lush campus that houses all the academic activities. This University emerged from the galaxy of institutions initially founded by the great philanthropist and educationist Dr. RM. Alagappa Chettiar during the 1950s. Alagappa University was brought into existence by a Special Act of the Government of Tamil Nadu in May 1985 to foster research, development, and dissemination of knowledge in various branches of learning and recognized by the University Grants Commission (UGC) of India. The University has 45 Departments, 9 Centres, and 2 Constituent Colleges on its campus as well as 44 Affiliated Colleges located in the districts of Sivaganga and Ramanathapuram are part of the University. Of which one Autonomous College and one Alagappa University Model Constituent College of Arts and Science are located in Kilakkarai.

The University offers education through Regular, Weekend, Distance, and Collaborative modes. Through all modes of education, the University caters to the needs of the student community of around **1.12 lakhs**. The University has International Collaborations with Universities / Institutions of Higher Learning in countries like the U.S.A, UK, Australia, Singapore, China, Malaysia, and South Korea. Innovative programmes are designed and offered at the University for foreign students. 2) FOR THE DEGREE

The candidates shall have subsequently undergone the prescribed programme of study in a College Affiliated with this University for not less than two academic years comprising 4 semesters, passed the examinations prescribed, and fulfilled such conditions as have been prescribed therefore.

3) DURATION

The programme is for two years. Each year shall consist of two semesters viz. Odd and Even semesters. Odd semesters shall be from June / July to October / November and Even semesters shall be from November / December to April / May. There shall be not less than 90 working days which shall comprise 450 teaching clock hours for each semester (exclusive of the days for the conduct of the University end-semester examination).

4) MEDIUM OF INSTRUCTION

The medium of instruction for all PG programmes is English except M.A., Tamil

5) **SEMESTERS**

An academic year is divided into two **Semesters.** In each semester, courses are offered in 15 teaching weeks and the remaining 5 weeks are to be utilized for the conduct of examination and evaluation purposes. Each week has 30 working hours spread over 5 / 6 days a week.

6) CREDITS

The term "Credit" refers to the weightage given to a course, usually in relation to the instructional hours assigned to it. Normally in each of the courses credits will be assigned based on the number of Lectures/Tutorials/Laboratory and other forms of learning required to complete the course contents in a 15-week schedule. One credit is equal to one hour of lecture per week. For laboratory/field work one credit is equal to two hours. The total minimum credits, required for completing a PG programme is 90. The details of credits for individual components and individual courses are given in the programme structure.

7) COURSE

Each **Course** is to be designed variously under lectures/tutorials/laboratory or field work/ seminar/ practical training/ assignments/term paper or report writing etc., to meet effective teaching and learning needs.

8) COURSES IN PROGRAMMES

A PG programme consists of many courses. The term "course" is applied to indicate a logical part of the subject matter of the programme and is invariably equivalent to the subject matter of a "paper" in the conventional sense. The following are the various categories of the courses suggested for the PG programmes:

- A. Core courses (CC) "Core Papers" means "the core courses" related to the programme concerned including practicals and project work offered under the programme and shall cover core competency, critical thinking, analytical reasoning, and research skill.
- B. **Discipline-Specific Electives (DSE)** means the courses offered under the programme related to the major but are to be selected by the students, shall cover additional academic knowledge, critical thinking, and analytical reasoning.
- C. Self-Learning Courses from MOOCs platforms (Voluntary/optional basis)

MOOCs shall be voluntary/optional for the students. Students have to undergo a total of 2 Self Learning Courses (MOOCs) one in the II semester and another in the III semester. The actual credits earned through MOOCs shall be transferred to the credit plan of programmes as extra credits. Otherwise, 2 credits/course be given if the Self Learning Course (MOOC) is without credit. While selecting the MOOCs, preference shall be given to the course related to employability skills.

D. Dissertation/ Project

Each candidate shall be required to take up a Project /Dissertation and submit a Report/thesis at the end of the second year. The Head of the Department shall assign the Guide who in turn will suggest the Project /Dissertation Work to the student at the beginning of the second year. The candidate should prepare three copies of the project report/thesis. One typed copy of the Project Report shall be submitted to the University through the Head of the Department on or before the date fixed by the University. The report /thesis will be evaluated by an Internal Examiner and an External Examiner, nominated by the University. The candidate concerned has to defend his project in a Viva— Voce examination. After evaluation, one copy will be retained in the department library, the guide will retain one copy and the student shall hold one copy. If the candidate is desirous of availing the facility from other Universities/laboratories/Organizations, they shall be permitted only after getting approval from the Guide and be informed to the HOD and Principal. In such a case, the candidate shall acknowledge the same in their dissertation/project. The format /certificate for the dissertation/project to be followed by the student is enclosed in **Annexure I**

G. Internship

The students shall undergo Internship / industrial training in reputed organizations for a minimum of two weeks to acquire industrial knowledge during the summer vacation of the second semester. The students have to find an industry related to their discipline (Public Limited/Private Limited/owner/NGOs etc.,) in consultation with the faculty in charge/Mentor and get approval from the Head of the Department and Departmental Committee before going for an internship / industrial training. The format (model) for the internship report to be followed by the student is enclosed in **Annexure II**.

Internship/Industrial Activity for PG

Objective	❖ Students are required to undergo either an Internship or an Industrial Activity during the summer vacation for a minimum period of 30 days between the first year of study, i.e., after the completion of the End Semester Examination of the second semester, as instructed by the Department HoD and faculty in consultation with the College Administration. A report on the Internship/Industrial Activity must be submitted to the Department after completing the Internship/Industrial Activity. Thereafter, the students shall appear for a Viva-Voce examination conducted by a panel consisting of the HoD and the faculty guide.
Evaluation	 ❖ The performance of students under this course will be assessed by the faculty guide, and the report submitted by the students will be evaluated by a panel constituted by the HoD. The panel will include the faculty-incharge, the Head of the Department, and one external member, for a total of 75 marks (50 marks for the report and 25 marks for the Viva-Voce). ❖ If a student fails to complete the training/internship and/or fails to submit the report on time, he/she must redo the training/internship in the subsequent semester or academic year, as decided by the Department Committee. ❖ If a student scores less than 40% (i.e., less than 30 marks) in the training/internship report evaluation, he/she must redo the training in the ensuing semester, as decided by the Department Committee. ❖ If a student scores 40% or above in the training report, but less than 40% (i.e., less than 10 marks) in the Viva-Voce, he/she must reappear for the Viva-Voce in the ensuing semester, as decided by the Department Committee. ❖ □ When a faculty guide is not available on the date of the Viva-Voce, the HoD will nominate another faculty member to the panel.

9) EXAMINATIONS and EVALUATION

The examinations shall be conducted separately for theory and practical to assess (remember, understand, apply, analyze, evaluate, and create) the knowledge required during the study. There shall be two systems of examinations viz., internal and external examinations. The internal examinations shall be conducted as Continuous Internal Assessment tests I and II (CIA Test I & II).

9.1 Internal Assessment

The internal assessment shall comprise a maximum of 25 (Theory & Practical) Marks for each course/subject. The following procedure shall be followed for awarding internal marks.

9.2 External Examination

- i) There shall be examinations at the end of each semester, for odd semesters in October / November; and for even semesters in April / May.
- ii) A candidate who does not pass the examination in any course(s) may be permitted to appear in such failed course(s) in the subsequent examinations to be held in October /

November or April / May. However, candidates who have arrears in Practical shall be permitted to take their arrear Practical examination only along with the Regular Practical examination in the respective semester.

- iii) A candidate should get registered for the first-semester examination. If registration is not possible owing to a shortage of attendance beyond the condonation limit/regulation prescribed OR belated joining OR on medical grounds, the candidates are permitted to move to the next semester. Such candidates shall re-do the missed semester after completion of the stipulated programme period.
- iv) Viva-Voce: Each candidate shall be required to appear for the Viva-Voce Examination (in defense of the Dissertation/Project/internship only).
- v) For the Project/Dissertation/Internship report, the maximum marks will be 50/100 for report/ thesis evaluation, and for the Viva-Voce it is 25/50 (if in some programmes, the project is equivalent to more than one course, the project marks would be in proportion to the number of equivalent courses).
- vi) The results of all the examinations will be published through the College/ University where the student underwent the course as well as through the University Website. In the case of private candidates, the results will be published through the Centre in which they took the examinations as well as through the University Website.

Attendance need not be taken as a component for continuous assessment, although the students should put in a minimum of 75% attendance in each course. In addition to the continuous evaluation component, the end semester examination, which will be a written examination of at least 3 hours duration, would also form an integral component of the evaluation. The ratio of marks to be allotted to continuous internal assessment and to end the semester examination is 25: 75. The evaluation of laboratory components, wherever applicable, will also be based on continuous internal assessment and an end-semester practical examination.

CONDONATION

Students must earn 75% of attendance in each course to appear for the examination. Students who have earned 74% to 70% of attendance are to be applied for condonation in the prescribed form with the prescribed fee. Students who have earned 69% to 60% of attendance are to be applied for condonation in the prescribed form with the prescribed fee along with the Medical Certificate. Students who have below 60% of attendance are not eligible to appear for the examination. They shall re-do the semester(s) after completion of the stipulated programme period.

RESULTS

The results of all the examination will be published through the Department where the Students underwent the course as well as through the College/University website.

PASSING MINIMUM

A candidate shall be declared to have passed each course if he/she secured not less than 40% marks in the External Examination and 40% marks in the Internal Assessment and not less than 50% in the aggregate, taking Continuous assessment and External examinations marks together.

A candidate shall be declared to have passed the Project/dissertation/internship if he/she gets not less than 40% in thesis/report and Viva-Voce but not less than 50% in the aggregate of both the marks for thesis/report and Viva-Voce.

A candidate who gets less than 40% in the Project/dissertation must resubmit the report/thesis. Such candidates need to take again the Viva-Voce on the resubmitted report/thesis.

- a) Successful candidates passing the examinations and earning a GPA between 9.0 and 10.0 and marks from 90 100 shall be declared to have Outstanding (O).
- b) Successful candidates passing the examinations and earning a GPA between 8.0 and 8.9 and marks from 80 89 shall be declared to have Excellent (D+).
- c) Successful candidates passing the examinations and earning a GPA between 7.5 7.9 and marks from 75 79 shall be declared to have Distinction (D).
- d) Successful candidates passing the examinations and earning a GPA between 7.0 7.4 and marks from 70 74 shall be declared to have Very Good (A+).
- e) Successful candidates passing the examinations and earning a GPA between 6.0 6.9 and marks from 60 69 shall be declared to have Good (A).
- f) Successful candidates passing the examinations and earning a GPA between 5.0 5.9 and marks from 50 59 shall be declared to have an Average (B).
- g) Candidates earning a GPA between 0.0 and marks from 00 49 shall be declared to have Re-appear (U).
- h) Absence from an examination shall not be taken as an attempt.

From the second semester onwards the total performance in a semester and continuous performance starting from the first semester are indicated respectively as Grade Point Average (GPA) and Cumulative Grade Point Average (CGPA). These two are calculated by the following formulate

The final result of the candidate shall be based only on the CGPA earned by the candidate.

- a) Successful candidates passing the examinations and earning a CGPA between 9.5 and 10.0 shall be given Letter Grade (O+), and those who earned a CGPA between 9.0 and 9.4 shall be given Letter Grade (O) and declared to have First Class –Exemplary*.
- b) Successful candidates passing the examinations and earning a CGPA between 7.5 and 7.9 shall be given Letter Grade (D), those who earned a CGPA between 8.0 and 8.4 shall be given Letter Grade (D++), those who earned a CGPA between 8.5 and 8.9 shall be given Letter Grade (D++) and declared to have First Class with Distinction*.
- c) Successful candidates passing the examinations and earning a CGPA between 6.0 and 6.4 shall be given Letter Grade (A), those who earned a CGPA between 6.5 and 6.9 shall be given Letter Grade (A++), those who earned a CGPA between 7.0 and 7.4 shall be given Letter Grade (A++) and declared to have First Class.

- d) Successful candidates passing the examinations and earning a CGPA between 5.0 and 5.4 shall be given a Letter Grade (B), and those who earned a CGPA between 5.5 and 5.9 shall be given a Letter Grade (B+) and declared to have passed in Second Class.
- i) Candidates who earned a CGPA between 0.0 and 4.9 shall be given Letter Grade (U) and declared to have Re-appear.
- e) Absence from an examination shall not be taken as an attempt.

Where 'Ci' is the Credit earned for Course i in any semester; 'Gi' is the Grade Point obtained by the student for Course i and 'n' refers to the semester in which such courses were credited.

CGPA (Cumulative Grade Point Average) = Average Grade Point of all the Courses passed starting from the first semester to the current semester.

Note: * The candidates who have passed in the first appearance and within the prescribed Semesters of the PG Programme are alone eligible for this classification.

10. SELF-FINANCING STREAM:

The above regulations shall be applicable also to the candidates undergoing the programmes in Self-Financing Stream.

11. GRIEVANCE REDRESSAL COMMITTEE:

The college shall form a Grievance Redressal Committee for each course in each Department with the Course Teacher and the HOD as the members. This committee shall solve all grievances relating to the Internal Assessment marks and other student-related activities.

12. REVISION OF REGULATIONS AND CURRICULUM:

The University may from time to time revise, amend and change the regulations and the curriculum if found necessary.

13. MAXIMUM DURATION OF THE COMPLETION OF THE PROGRAMME:

The maximum period for completion of a PG Degree shall not exceed eight semesters continuing from the first semester.
