About Alagappa University

Alagappa University is located at Karaikudi in Tamil Nadu and occupies a sprawling 440-acre greenery and lush campus that houses all the academic activities. This University emerged from the galaxy of institutions initially founded by the great philanthropist and educationist Dr. RM. Alagappa Chettiar during the 1950s. Alagappa University was brought into existence by a Special Act of the Government of Tamil Nadu in May 1985 to foster research, development, and dissemination of knowledge in various branches of learning and recognized by the University Grants Commission (UGC) of India. The University has 45 Departments, 9 Centres, and 2 Constituent Colleges on its campus as well as 44 Affiliated Colleges located in the districts of Sivaganga and Ramanathapuram are part of the University. Of which one Autonomous College and one Alagappa University Model Constituent College of Arts and Science are located in Kilakkarai.

The University offers education through Regular, Weekend, Distance, and Collaborative modes. Through all modes of education, the University caters to the needs of the student community of around **1.12 lakhs**. The University has International Collaborations with Universities / Institutions of Higher Learning in countries like the U.S.A, UK, Australia, Singapore, China, Malaysia, and South Korea. - ii) For the Degree: The candidates shall have subsequently undergone the prescribed course of study in a college affiliated with this University for a period of not less than three academic years, passed the examinations prescribed, and fulfilled such conditions as have been prescribed, therefore.
- iii) Lateral Entry: The students qualified with the Diploma in Commercial Practice/Diploma in Modern Office Practice [10+3 (SSLC and Diploma)/ 10+2+2 (SSLC, HSC, and Diploma)] are eligible for admission into the lateral entry of all branches of UG Commerce/ Corporate Secretaryship/Computer Science/Electronics Degree Programmes.

2. DURATION:

The Programme is for a period of three years. Each academic year shall comprise two semesters viz. Odd and Even semesters. Odd semesters shall be from June / July to October / November and Even Semesters shall be from November / December to April /May.

There shall be not less than 90 working days, which shall comprise 450 teaching clock hours for each semester (Exclusive of the days for the conduct of university end-semester examinations).

5. THE CBCS SYSTEM:

All programmes (named after the core subject) mentioned earlier shall be run on the Choice Based Credit System (CBCS).

SEMESTERS: An academic year is divided into two Semesters. In each semester, courses are offered in 15 teaching weeks and the remaining 5 weeks are to be utilized for conduct of examinations and evaluation purposes. Each week has 30 working hours spread over 5 / 6 days a week.

6. CREDITS:

The Term "Credit" refers to the weightage given to a course, usually in relation to the instructional hours assigned to it. Normally in each of the courses credits will be assigned on the basis of the number of lectures/tutorials/laboratory and other forms of learning required to complete the course contents of a 15-week schedule. One credit is equal to one hour of lecture per week. For laboratory/field work one credit is equal to one or two hours. The total minimum credits, required for completing a UG programme is 140. The details of credits for individual components and individual courses are given in Tables -1(A) & 1(B).

7. COURSES:

Each course is to be designed variously under lectures/tutorials/laboratory or field work/seminar / practical training / Assignments / Term paper or Report writing etc., to meet effective teaching and learning needs.

8. COURSES IN PROGRAMMES:

The UG programme consists of a number of courses. The term 'course' is applied to indicate a logical part of the subject matter of the programme and is invariably equivalent to the subject matter of a 'paper' in the conventional sense. The following are the various categories of courses suggested for the UG programmes.

Part I –T/OL (Tamil or Hindi or Sanskrit or Arabic, French or special subject designed in lieu of the above)

Part II – English Language (EL) or special subject designed in lieu of the above

The Tamil/other languages and English Language courses are 4 each in number and the T/OL and EL are meant to develop the students' communicative skills at the UG level. They are the basic courses compulsorily required for each programme of study.

Part III includes

A. Core Course (CC)

Core courses are the basic courses compulsorily required for each programme of study. These will be related to the subject of the programme in which the candidate gets his / her degree (Core Competency, critical thinking, analytical reasoning, research skill & teamwork.)

B. Allied (AC)

Within the faculty, the students shall undergo two discipline-specific allied courses (one in the first year and another in the second year of his/her study except for computer application). The students of each Department may select two Allied courses each from two disciplines

C. Discipline Specific Elective (DSE)

Discipline-specific elective –Additional academic knowledge mostly related to skills, critical thinking, and analytical reasoning. It is a student choice - either Internship or Theory papers or Project + 2 or 3 theory papers.

Internship:

The students who have opted for an Internship must undergo industrial training in reputed organizations to accrue industrial knowledge in the final semester. The student has to find an industry related to their discipline (Public Limited/Private Limited/owner/NGOs etc.,) in consultation with the faculty in charge and get approval from the Departmental Committee and head of the department before going for an internship.

Internship/Industrial Activity for UG		
Objective	Students will have to undergo either Internship or Industrial Activity during the summer vacation for minimum period 30 days between II year course of study that is after Completion of End Semester Examination of IV Semester as instructed by the Department HOD and Faculty after consultation with College Administration. A Internship training/ Industrial Activity report should be submitted to the Department after completing the Intership/Industrial Visit. Thereafter the students will appear for a Viva- Voce examination conducted by a Panel consisting of the HoD, and faculty guide.	

	❖ The performance of students under this course will be assessed by the Faculty Guide/in charge and the report submitted by the students will be evaluated by the Faculty Guide and the Head of the Department.
	❖ A Viva-Voce will be conducted by a panel consisting of the HOD and the Faculty Guide.
Evaluation	❖ If a student fails to complete the training and / or fails to submit the internship report in time, he / she has to redo the internship in the ensuing semester or academic year as decided by the Department.
	❖ If a student scores less than 40 % (i.e., less than 30 marks) in the report, he / she has to redo the internship in the ensuing semester as decided by the Department committee.
	❖ If a student scores 40 % or above in the internship report, but scores less than 40 % (10 marks) in the Viva Voce, he / she has to reappear for the Viva Voce in the ensuing semester as decided by the Department committee.
	When a faculty guide is not present on the date of the Viva Voce, the HOD will nominate some other faculty to the Panel.

If internship— Marks = Internal examination - Two midterm evaluation through Viva voce + Report =25/50 Marks. External examination - Report (50/100 Marks) + Viva voce (25/50 Marks) = Total Internal + external marks 100/200.

Project/Dissertation

The duration of the Project/Dissertation shall be a minimum of three months in the Fifth/Sixth semester.

Plan of work

The candidate shall undergo Project/Dissertation Work during the Fifth/final semester. The candidate should prepare a scheme of work for the dissertation/project and should get approval from the guide. The candidate, after completing the dissertation /project work, shall be allowed to submit it to the departments at the end of the final semester. If the candidate is desirous of availing the facility from other departments/universities/ laboratories/ organizations they shall be permitted only after

getting approval from the guide and be informed to the HOD. In such a case, the candidate shall acknowledge the same in their dissertation/project work.

No. of copies of the intership/dissertation/project report

The candidate should prepare three copies of the internship/dissertation/project report and submit the same for evaluation by the examiners. After evaluation, one copy will be retained in the department library, the guide will retain one copy and the student shall hold one copy.

Format to be followed for internship/dissertation/project report

Internship report

The certificate format for the internship report to be followed by the student is **enclosed in Annexure** –I

The format /certificate for the thesis to be followed by the student is enclosed in **Annexure-II**

Part IV -It consists of the following categories

Skill Enhancement Course (SEC) – Exposure beyond the discipline (Value Education, Entrepreneurship course, Computer application for science, etc.,).

Foundation Course

The Foundation course is offered in Semester I under Part IV to ease the transition of students' learning from higher secondary to higher education.

Common Course

- The Environmental Studies course in fourth Semester and Value Education in Fifth Semester are provided as common courses under Part IV
- ii. Extension activity: These should be carried out outside the class hours.
- iii. Professional Competency Skill Course in Six Semester as common courses under Part IV.

Non-Major Elective

a) Those who have not studied Tamil up to XII standard and opted for other languages under Part I shall have to take two courses of Tamil (level will be at 6th Standard).

- b) Those who have studied Tamil up to XII standard and opted for other languages under Part I shall have to take course in adipadai Tamil. However, those who have studied Tamil upto X Std shall opt for Adipadai Tamil in NME.
- c) The student shall undertake Non-Major Elective courses one in the third semester and another one in the fourth semester or the student can opt for MOOCs Self learning courses (SLC) on a voluntary basis and students have to undergo a total of 2 SLC (One in third and another in the fourth semester).
- d) Naan Mudhalvan Course added in II ,III, IV,V and VI Semester as additional credits and compulsory .

NCC – National Cadet Corps courses be offered as optional courses for NCC Cadets (add-on credits)- Students who desire for NCC program shall participate compulsorily for a period of not less than three years (6 semesters). The student's performance shall be examined by the staff in charge of extension activities (NCC officers).

9. EXAMINATION AND EVALUATION:

The examinations shall be conducted separately for theory and practical's to assess (remember, understand, apply, analyse, evaluate, and create) the knowledge required during the study. There shall be two systems of examinations viz., internal and external examinations. The internal examinations shall be conducted as Continuous Internal Assessment tests I and II (CIA Test I & II).

A. Internal Assessment

The internal assessment shall comprise a maximum of 25 marks (theory)/25 Marks (Practical) for each subject. The following procedure shall be followed for awarding internal marks.

NCC –(add on courses) Theory – 25 Marks and Practical 25 Marks:

The internal marks shall be sent to the Controller of Examinations before the commencement of the final semester examinations.

The following parameters may be assessed for internal examination,

- > Regularity of attendance
- > Active Participation in classes/camps/games/special Camps/programmes in the college/District/ State/ University activities.
- > Exemplary awards/Certificates/Prizes.
- > Other Social components such as Blood Donations, Fine Arts, etc.

The above activities shall be conducted outside the regular working hours of the college. The mark sheet shall carry the gradation relevant to the marks awarded to the candidates.

B. External Examination

- > There shall be examinations at the end of each semester, for odd semesters in October / November; and for even semesters in April / May.
- A candidate who does not pass the examination in any course(s) may be permitted to appear in the failed course(s) in the subsequent examinations to be held in October / November or April / May. However, candidates who have arrears in Practical shall be permitted to take their arrear Practical examination only along with the Regular Practical examination in the respective semester.
- A candidate should get registered for the first-semester examination. If registration is not possible owing to a shortage of attendance beyond the condonation limit /regulation prescribed OR belated joining OR on medical grounds, the candidates are permitted to move to the next semester. Such candidates shall re-do the missed semester after completion of the stipulated programme period.
- For the Project Report/ Dissertation Work/internship the maximum marks will be 75/100 for project/internship report evaluation and for the Viva-Voce it is 25/50 (if in some programmes, the project is equivalent to more than one course, the project marks would be in proportion to the number of equivalent courses).
- ➤ Viva-Voce: Each candidate shall be required to appear for the Viva-Voce Examination (in defense of the Dissertation Work /Project/ internship).
- ➤ Candidates studying Sanskrit in a Language Course are permitted to write the Examinations in Sanskrit or English or Tamil. While answering in Sanskrit "Devanagari Script" alone is used.
- ➤ NCC (if introduced): Similar to the other courses theory and practical candidates should register for external examination.

11. CONDONATION:

Students must have 75% of attendance in each course to appear in the examination. Students who have 74% to 70% of attendance shall apply for condonation in the prescribed form with the prescribed fee. Students who have 69% to 60% attendance shall apply for condonation in the prescribed form with the prescribed fee along with the Medical Certificate. Students who have below 60% of attendance are not eligible to appear for the examination. They shall re-do the semester(s) after completion of the stipulated programme period

12. RESULTS:

The results of all the examinations will be published through the Department where the student underwent the course as well as through the College/University Website.

Passing minimum

- ➤ The passing minimum for University Examinations shall be 40% out of 75 marks (i.e. 30 marks) for Theory papers and 40% out of 75 marks (i.e. 30 marks) for Practical papers.
- A candidate shall be declared to have passed the Dissertation /Project report/Internship report if he/she gets not less than 40% in each of the Report and Viva-Voce.
- ➤ A candidate who gets less than 40% in the Dissertation /Project report/Internship report must resubmit the Project Report. Such candidates need to take again the Viva-Voce on the resubmitted report.

13. MAXIMUM DURATION OF THE COMPLETION OF THE PROGRAMME:

The maximum period for completion of a UG Degree shall not exceed Ten semesters continuing from the first semester.

14. CONFERMENT OF THE UNDERGRADUATE DEGREE PROGRAMME:

A candidate shall be eligible for the conferment of the Degree only after he/ she has earned the minimum required credits for the Programme prescribed, therefore (i.e. 140 + Extra Credits for three years UG Programmes and 160 + Extra credits for four years UG Programmes).

15. SELF-FINANCING STREAM:

The above Regulations shall be applicable also to the candidates undergoing the programmes in the Self-Financing Stream.

16. GRIEVANCE REDRESSAL COMMITTEE:

The College shall form a Grievance Redressal Committee for each course in each department with the Course Teacher and the HOD as the members. This Committee shall solve all grievances relating to the Internal Assessment marks of the students.
